During the evidentiary hearing, the Commission asked Kansas City Power & Light Company ("KCP&L") to supply information regarding extension tariffs.<sup>1</sup> The Commission will order KCP&L to respond to the Commission's query.<sup>2</sup>

The Commission's query includes, but is not limited to, the similarities and differences between KCP&L and KCPL Greater Missouri Operations' tariffs on new residential development main line extensions, how the deposits and reimbursements are determined, how each company operates its program, what appliances and HVAC systems qualify, the value of each qualifying item, and what authority the utilities have to make those determinations. Also, KCP&L should provide insight into how these programs collaborate with MEEIA, if at all. Any other party may also respond.

#### THE COMMISSION ORDERS THAT:

1. Kansas City Power & Light Company Commission shall respond as ordered above no later than April 10, 2017.
