On June 1, 2016¹, Kansas City Power & Light Company filed tariff sheets to modify its Demand Side Investment Mechanism ("DSIM"). The Commission rejected those tariff sheets on July 20, and ordered KCP&L to file tariff sheets that complied with the order.

On July 22, KCP&L filed a tariff in an attempt to comply with the Commission's July 20 order. KCP&L also filed a motion for expedited treatment in which it asks the Commission to approve the tariff by August 1.

The Commission will order its Staff to either file a Recommendation or a pleading that states when it can file its Recommendation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall respond as ordered above no later than noon, July 25, 2016.
