No later than 30 days from filing date of the pending tariff and application, ¹ Staff's recommendation is due, ² and the Commission will set a date for filing any reply to the recommendation. ³ Parties to the general rate case in which the Commission approved the fuel adjustment clause are parties to this case without having to file an application for intervention. ⁴ The Commission will direct its Data Center to add those parties to the service list. For anyone else, the Commission will set a deadline for filing an application to intervene. ⁵ The tariff bears a proposed effective date of May 25, 2017.

THE COMMISSION ORDERS THAT:

- 1. Any application for intervention shall be filed no later than April 3, 2017.
- 2. Staff's recommendation shall be filed no later than April 24, 2017.
- 3. Any response to the recommendation is due on May 4, 2017.
