**NOTICE OF HEARING, ORDER DIRECTING NOTICE,
SETTING CONFERENCE DATE, ESTABLISHING
INTERVENTION DATES, AND DIRECTING FILINGS**

On January 30, 2018, Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") filed tariffs that would implement a general rate increase for electric service. The Commission will direct notice of this action, set dates for a hearing and a conference, and provide for certain filings.

THE COMMISSION ORDERS THAT:

1. Preliminary Schedule. The following schedule is ordered.¹

2. Conference and Hearing Location. Each hearing or conference will convene in Room 310, Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. That building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the event. Such contact shall be through the Commission’s Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711. Any party may participate in pre-hearing conference by telephone by dialing 877-820-7831, and entering PIN 35666479# at the start time of the conference.

3. Intervention. Any application to intervene shall be filed by transmitting it to:

4. Other Filings. Staff shall coordinate, and jointly file on behalf of all parties in agreement, proposed orders:

- a. Setting a procedural schedule. Any proposed order setting a procedural schedule shall include proposed cut-off dates for service of discovery requests and responses, and dates for discovery conferences, and dates for rulings.

- b. Other provisions governing discovery.
- c. Provisions governing prepared testimony.
- d. Setting local public hearings.

5. Notice of this Action. The Commission's Data Center shall send a copy of this notice and order to the county commission of each county within KCP&L's and GMO's service area. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing KCP&L's and GMO's service area, and to the news media serving KCP&L's and GMO's service area.

6. Effective Date of this Notice and Order. This notice and order shall be effective when issued.
