On April 20, 2022, Union Electric Company d/b/a Ameren Missouri filed a revised tariff sheet designed to extend the Voluntary Green/Pure Power pilot program through December 31, 2024. Ameren Missouri stated that the revision was consistent with the stipulation and agreement approved in its rate case. The tariff sheet bears an effective date of May 20, 2022.

The Commission will direct its Staff to file a recommendation regarding the tariff revision. The Commission will also set a date for any other party to file a response or recommendation regarding the tariff revision.

THE COMMISSION ORDERS THAT:

1. No later than May 2, 2022, at 11:00 a.m. Staff shall file a recommendation regarding the tariff revision, Tracking No. YE-2022-0249.
2. Any other party wishing to file a response or recommendation shall do so no later than May 2, 2022, at 11:00 a.m.
3. This order is effective when issued.
