On April 9, 2020, The Empire District Electric Company (Empire) filed its request for relief from having to file position statements or, in the alternative, move the filing of position statements until after the parties make any additional offers of evidence. In support of its motion, Empire says that the parties positions will be contained in their briefs, Empire employees and witnesses would like to focus on their families over the Easter holiday, and settlement of the case is more likely if the parties focus on settlement.

The Office of the Public Counsel (OPC) filed a response in opposition to granting relief from filing position statements. In support of its response, OPC states: "Public Counsel expected that the Commissioners might ask questions of the parties and have them answered on the record and, further, that the Commissioners would want to be informed by the parties of their positions on their issues to be better informed before the Commissioners posed such questions."

Position statements were not included in the proposed procedural schedule put forth by the parties in Staff's motion to cancel the evidentiary hearing. The position statements were added to the procedural schedule for the reasons deduced by OPC. Position statements assist the Commission in understanding essential conflicts between the parties on disputed issues prior to hearing.

In recognition of the parties' efforts to resolve many of the disputed issues prior to hearing or case submission, the Commission will extend the time to file position statements to coincide with additional offers of evidence. The parties only have to provide position statements as to issues that are still in dispute at that time.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is modified. The parties shall file position statements on disputed issues no later than April 17, 2020.

2. This order is effective when issued.
