**ORDER GRANTING MOTION FOR CORRECTION**

On May 9, 2018, the Commission issued its Order Resolving Annual Fuel Adjustment Clause True-Up and Tariff (“Order”). On May 10, 2018, the Staff of the Commission filed its Motion for Clarification and Correction (“Motion”).

In the Motion, Staff explains that the Order found that the requested adjustment would increase a typical residential customer’s bill about \$0.27 per month. What the Staff Recommendation stated, however, was that the rate for the Fuel Adjustment Charge would increase from \$0.27 to \$2.34 per month, for an increase of \$2.07. Staff asks the Commission to correct the finding in its order to comport with the Staff Recommendation.

The Commission finds Staff’s motion reasonable, and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s May 9, 2018 Order Resolving Annual Fuel Adjustment Clause True-Up and Tariff is clarified and corrected as stated above.

2. This order shall be effective when issued.
