On March 23, 2018, Union Electric Company d/b/a Ameren Missouri submitted its 24th Fuel Adjustment Clause (FAC) true-up filing (File No. ER-2018-0256) and a tariff sheet to adjust the company's FAC for the 27th accumulation period (File No. ER-2018-0255). The Commission directed Staff to submit recommendations on Ameren Missouri's FAC filings. On April 23, 2018, a *Staff Recommendation to Approve Tariff Sheet Regarding Change to the Fuel Adjustment Rates for Accumulation Period 27* and *Staff Recommendation to Approve True-Up Filing for Ameren Missouri's Adjustment Clause for the 24th Recovery Period* were filed.

The Commission will set a deadline for parties to submit responses to Staff's recommendations.

THE COMMISSION ORDERS THAT:

1. Responses to Staff's recommendations may be filed no later than April 27, 2018.

2. This order shall be effective when issued.
