# ORDER DIRECTING NOTICE, ESTABLISHING INTERVENTION DATE, AND DIRECTING FILING OF STAFF RECOMMENDATION

On June 1, 2018, KCP&L Greater Missouri Operations Company (GMO) filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism Rider. Commission Rule 4 CSR 240-20.093(4) requires the Commission's Staff to examine and analyze the information GMO has filed and to submit a recommendation no later than 30 days after GMO filed its tariff revision. Because that 30<sup>th</sup> day falls on a Saturday, Staff's recommendation will be due no later than Monday, July 2, 2018. The Commission must then act on GMO's tariff filing before August 1, 2018.

The Commission will establish a deadline for any other entity that may wish to apply to intervene and will direct its Data Center to serve a copy of this order upon the parties in EO-2015-0241 and upon the county commission of each county in GMO's service area. In addition, the Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving GMO's service area and to the members of the Missouri General Assembly representing the residents of GMO's service area.

#### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall add all parties from File No. EO-2015-0241 to the service list for this case.

- 2. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in the service territory of KCP&L Greater Missouri Operations Company.
- 3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing the residents of the service area of KCP&L Greater Missouri Operations Company and to the news media serving the residents of the service territory of KCP&L Greater Missouri Operations Company.
- 4. Any proper person or entity wishing to intervene in this matter shall file an application to intervene no later than June 15, 2018.
- 5. The Staff of the Commission shall file its recommendation no later than July 2, 2018.
  - 6. This order shall be effective when issued.
