STAFF RECOMMENDATION

COMES NOW Staff of the Missouri Public Service Commission and submits the accompanying Staff Recommendation memorandum (which is incorporated herein by reference) pursuant to the Commission's April 28, 2022, Order Directing Staff Recommendation. In support thereof, Staff further states as follows:

1. On April 20, 2022, Union Electric Company d/b/a Ameren Missouri filed a revised tariff sheet designed to extend the Voluntary Green/Pure Power pilot program through December 31, 2024. Ameren Missouri stated that the revision was consistent with the stipulation and agreement approved in its 2019 rate case. The tariff sheet bears an effective date of May 20, 2022. The tariff sheet was assigned Tariff Tracking No. YE-2022-0249.

2. As reflected in the Staff Recommendation memorandum, the Commission Staff's Tariff/Rate Design Department has reviewed the filed tariff sheet and recommends the Commission issue an order approving the following tariff sheet, as filed on April 20, 2022, for service on and after May 20, 2022, the requested effective date.

Ameren Missouri Operations Filing

On April 20, 2022, Union Electric Company, d/b/a Ameren Missouri (“Ameren Missouri”), filed with the Commission one (1) tariff sheet¹ bearing an issue date of April 20, 2022 and an effective date of May 20, 2022, proposing to extend the Voluntary Green/Pure Power pilot program through December 31, 2024. Pilot Program customers that choose to transition will be given priority for Rider CSP enrollment or on any waitlist and will be considered to have been enrolled in Rider CSP from the date of their pilot Program enrollment.

Ameren Missouri stated that the revision listed above was consistent with the stipulation and agreement approved in its 2019 rate case, ER-2019-0335. The Commission issued its Order Directing Staff Recommendation on April 28, 2022, which directed Staff to file its recommendation no later than May 2, 2022, at 11:00 a.m.

Staff Recommendation

The Commission Staff's Tariff/Rate Design Department has reviewed the filed tariff sheet and recommends the Commission issue an order approving the following tariff sheet, as filed on April 20, 2022, for service on and after May 20, 2022, the requested effective date.




