For anyone else, the Commission will set a deadline for filing an application to intervene.⁵ The tariff bears a proposed effective date of May 25, 2017.

- 1. Any application for intervention shall be filed no later than April 3, 2017.
- 2. Staff's recommendation shall be filed no later than April 24, 2017.
- 3. Any response to the recommendation is due on May 4, 2017.
