APPLICATION FOR APPROVAL OF INTERCONNECTION AGREEMENT

COMES NOW McLeodUSA Telecommunications Services, Inc., (McLeodUSA), and files its Application for Approval of Interconnection Agreement (Agreement) between McLeodUSA and Southwestern Bell Telephone Company (SWBT) under the Telecommunications Act of 1996 (Federal Act). In support of that Application, McLeodUSA states as follows:

I. INTERCONNECTION AGREEMENT REACHED

McLeodUSA presents to this Commission for approval an Interconnection Agreement entered into between SWBT and McLeodUSA, executed pursuant to the terms of the Federal Act. A copy of the Agreement is provided as Exhibit A. This Interconnection Agreement adopts the terms of the Interconnection Agreement between Northpoint Communications, Inc., (Northpoint) and SWBT¹ pursuant to Section 252(i) of the Federal Act. This Agreement was executed by McLeodUSA on July 2, 1999, and by SWBT on July 8, 1999. The Agreement



¹The Interconnection Agreement between Northpoint and SWBT which is adopted by the Interconnection Agreement filed herein was approved by the Commission by Order issued January 6, 1999, in Case No. TO-99-168 (See footnote *** on seriatim page number 38). SWBT has reserved certain rights in footnotes * and **, pending appeal of the Commission's Order in Case Nos. TO-97-40 and TO-98-115, and asserts in footnote * on Page 32 of 33 (seriatim page number 37) of this Interconnection Agreement that "Southwestern Bell has signed this document under compulsion of federal and/or state law".

consists of 626 pages numbered seriatim, including 24 attachments, 14 appendices, and 2 exhibits which are incorporated into the Agreement. There are no outstanding issues between McLeodUSA and SWBT that need the assistance of mediation or arbitration.

II. REQUEST FOR APPROVAL

McLeodUSA seeks the Commission's approval of the Agreement, consistent with the provisions of the Federal Act and Missouri law. The implementation of this Agreement complies fully with Section 252(3) of the Federal Act because the Agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier.

McLeodUSA respectfully requests that the Commission grant expeditious approval of this Agreement, without change, suspension or other delay in its implementation. This is a bilateral agreement, reached as a result of negotiations and compromise between the parties.

The agreement has been stamped with seriatim page numbers; thus, the Commission should not need to order an additional page-numbered copy to be filed upon approval.

III. STANDARD FOR REVIEW

The statutory standards of review are set forth in Section 252(e) of the Federal Act which provides as follows:

- (e) Approval by State Commission
 - (1) Approval required.—Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A State commission to which an agreement is submitted shall approve or reject the agreement, with written findings as to any deficiencies.

- (2) Grounds for rejection.--The state commission may only reject--
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that--
 - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
 - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity.

IV. MISSOURI LAW

The executed Agreement is consistent with Missouri Law.

V. CONCLUSION

For the reasons set forth above, McLeodUSA respectfully requests that the Commission approve the Agreement expeditiously.
