ORDER APPROVING TARIFFS

Issue Date: March 29, 2007

Effective Date: April 2, 2007

Syllabus: This order approves the tariff sheets filed by Algonquin Water Resources of Missouri, LLC.

On March 13, 2007, the Commission issued its Report and Order. To attempt to comply with that Report and Order, Algonquin filed both water and sewer tariff sheets on March 20, 2007, and asked for the Commission to approve those sheets no later than April 2. Algonquin filed substitute tariff sheets on March 28. The Office of The Public Counsel objects.

The Staff of the Commission filed its Recommendation on March 28. Staff states that the tariff sheets, as substituted on March 28, comport with the Commission's Report and Order, and recommends that the Commission approve them, and that the Commission find good cause to waive the 30-day effective date and approve them on an expedited basis.

OPC's argument is based upon its Application for Rehearing, which the Commission has denied under separate order. Therefore, the Commission again rejects those arguments.

The Commission reviewed the tariff filings and the Staff Recommendation, and determines that the filings comply with the Commission's order. The Commission further finds good cause for Algonquin to be excused from the Section 393.140(11) requirement that tariffs have a 30-day effective date, as failure to expeditiously approve the tariffs would result in Algonquin being unable to recover for water it supplies for golf course irrigation at Holiday Hills.

IT IS ORDERED THAT:

1. The Office of the Public Counsel's Objection to Algonquin's Motion for Expedited Treatment and Motion to Reject Tariff Sheets or, in the Alternative, to Suspend Tariff Sheets is denied.

2. The tariff filed on March 20, 2007, Tariff No. YW-2007-0650, by Algonquin Water Resources of Missouri, LLC, as substituted on March 28, 2007, is approved to become effective on April 2, 2007. The tariff sheet approved is:
