SUPPLEMENT TO APPLICATION

COMES NOW Hotel Connect Management, Inc. ("Hotel Connect" or "Applicant") and files this supplement to its application previously filed with the Missouri Public Service Commission on December 1, 1999 in order to clarify and supplement the same. In support thereof, Hotel Connect provides the following information:

1. In paragraph 14 of its application, Applicant requested that Section 393.280-Depreciation Rates be waived by the Commission. Applicant notes that such section should be Section 392.280-Depreciation Rates and requests waiver of the requirements under such provision. In addition, Applicant requests waiver of all other regulations and statutory sections as previously set out in its application.


2. Applicant also states that considerations of the public interest and particularly equitable access for potential subscribers to service who reside in the area sought to be certificated warrant the granting of this application in that Applicant will extend the benefits of competition into the intrastate interexchange market, increase the diversity of choice and supply of telecommunications services and products in exchanges in which it will offer service and shall increase consumer access to competitive and affordable telecommunications services.

3. Applicant makes such additions and alterations to its application previously filed with the Missouri Public Service Commission and incorporates all other information set out in such application and the exhibits attached thereto as if such documents were filed simultaneously with this supplement.

WHEREFORE, Applicant Hotel Connect Management, Inc. respectfully requests the Commission to grant it a Certificate of Authority to provide competitive intrastate interexchange telecommunications service within the state of Missouri; an order classifying it as a competitive telecommunications company providing competitive service; an order suspending, waiving, or modifying the above-referenced rules and statutory provisions as they relate to the regulation of the Applicant in the state of Missouri; and for such further orders as the Commission deems appropriate.
