SECOND STATUS REPORT

COMES NOW Missouri-American Water Company (MAWC), on behalf of itself, and the Staff of the Missouri Public Service Commission (Staff), Office of the Public Counsel, Midwest Energy Consumers Group, Missouri Industrial Energy Consumers, The Empire District Electric Company, City of Riverside, City of St. Joseph, Municipal League of Metro St. Louis, Public Water Supply District No. 2 of Andrew County, Sunnydale Properties, and Triumph Foods, LLC,¹ and, as a *Second Status Report*, states as follows to the Missouri Public Service Commission (“Commission”):

1. On February 26, 2021, MAWC, on behalf of the parties to this case, filed a *Status Report* wherein it indicated that a draft stipulation and agreement had been prepared and circulated to the parties and that the attachments called for by the draft stipulation were being prepared. The parties further requested that they be directed to file a stipulation and agreement or a status report by March 3, 2021. The Commission granted this request by its order issued on March 1, 2021.

2. Since that time, the parties have continued to meet and have worked to finalize both the stipulation and agreement and attachments that would memorialize a global settlement. Unfortunately, that process is not likely to be concluded in time for a stipulation and agreement to

be filed today. The parties therefore request that they be further directed to file a stipulation and agreement or a status report by March 8, 2021.

WHEREFORE, MAWC requests that the Commission consider this *Second Status Report* to comply with its order and further order the parties to file a stipulation and agreement or a status report as described herein.
