ORDER GRANTING REQUEST FOR EXTENSION

On July 1, 2022, Missouri-American Water Company (MAWC) filed tariff sheets designed to implement a general rate increase of approximately 25.7% annually for water and sewer services. Along with those tariffs, MAWC filed a Motion to Establish Test Year, True-Up Date, and Discrete Adjustments (Motion). Commission Rule 20 CSR 4240-2.080(13) provides that unless the Commission sets a different time for response, parties are allowed ten days to respond to any motion. Under that rule, any response to MAWC's motion would be due on July 11, 2022.

On July 11, 2022, the Office of the Public Counsel filed a Request for Extension.¹ OPC explains that the Commission should allow until at least July 29, 2022 for potential intervenors to respond to the Motion.

The Commission finds OPC's request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. OPC's Request for Extension is granted.
2. Responses to the Motion are due no later than July 29, 2022.

¹ In the alternative, OPC objects to the Motion.

3. This order shall be effective when issued.
