The Commission had scheduled a combined in-person and virtual local public hearing in St. Louis for January 25, 2023. Due to a forecast of inclement weather, the Commission postponed the in-person portion of the hearing.

The Commission will now reschedule the in-person portion of the hearing.

THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing. The formal hearing will begin at the conclusion of the question and answer session.

2. Missouri-American Water Company, the Staff of the Commission, and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer session. Any other party may also choose to have a representative present.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the media and the General Assembly representing customers in Missouri-American Water Company's service area.

4. Comments at the hearing will be limited to five minutes per person.

5. In-person hearings will not be broadcast by WebEx or by any other means. Those wishing to participate in the in-person hearings must attend in-person. No preregistration is needed for attending an in-person hearing.
