APPLICATION

COMES NOW Ozark Shores Water Company (hereinafter “Applicant” or “Company”), pursuant to 4 CSR 240-3.640(7), Section 393.170, RSMo 2000 and 4 CSR 240-2.060(4)(A), and for its application states the following to the Missouri Public Service Commission (“Commission”):

1. Applicant is a Missouri corporation duly organized and existing under and by virtue of the laws of the State of Missouri with its principal office and place of business located at P.O. Box 9, 62 Bittersweet Road, Lake Ozark, Missouri 65049. Pursuant to 4 CSR 240-2.060 (1)(B), Applicant’s certificate of good standing from the Missouri Secretary of State’s office is attached as **Appendix 1**.

2. Applicant currently provides water services to members of the public in an unincorporated area of Camden County, Missouri and, accordingly, is subject to the jurisdiction, control and regulation of the Commission as provided by law.

4. Applicant's annual report respecting its regulated water operations is due to be filed on April 15, 2011.

5. Applicant desires an extension of time up to and including July 31, 2011 within which to file its annual report. Although auditors are at work in compiling the necessary information by which to complete the report, they are not expected to complete their work in time for the Company to meet the April 15, 2011 deadline.

6. This request is not for purposes of delay. If granted it will not prejudice any other party but will allow the Company to accurately compile the needed documentation and information for its annual report to the Commission.

7. Applicant has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates in which action, judgment or decision has occurred within three (3) years of the date of this application.

8. Applicant has no annual report or assessment fees which are currently overdue.

9. There are no cases pending where the Company's activities are the primary focus of the proceedings. Therefore, Applicant is not obligated to serve this pleading on parties not named in the certificate below.

WHEREFORE, Ozark Shores Water Company respectfully requests that the Commission extend the time within which it may file its annual report(s) to July 31, 2011.
