COMES NOW Lake Region Water & Sewer Company (hereinafter “Applicant” or “Company”), pursuant to 4 CSR 240-3.335(7) and 4 CSR 240-3.640(7) Section 393.170, RSMo 2000 and 4 CSR 240-2.060(4)(A), and for its application states the following to the Missouri Public Service Commission (“Commission”):

1. Applicant is a Missouri corporation duly organized and existing under and by virtue of the laws of the State of Missouri with its principal office and place of business located at 62 Bittersweet Road, Lake Ozark, Missouri. Pursuant to 4 CSR 240-2.060 (1)(B), Applicant’s certificate of good standing from the Missouri Secretary of State’s office is attached as **Appendix 1.**

2. Applicant currently provides water and sewer services to members of the public located in an unincorporated area of Camden County, Missouri and, accordingly, is subject to the jurisdiction, control and regulation of the Commission as provided by law.

4. Applicant's annual report(s) respecting its regulated water and sewer operations are due to be filed on April 15, 2011.

5. Applicant desires an extension of time up to and including July 31, 2011 within which to file its annual report(s). Although auditors are at work in compiling the necessary information by which to complete the reports, they are not expected to complete their work in time for the Company to meet the April 15, 2011 deadline.

9. Applicant has filed for additional certificated territory in Case No. SA-2011-0174 but there are no other parties to that case other than the Commission Staff and the Office of Public Counsel. The certificate of service below covers all parties to the case.
