## ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING REQUESTS TO INTERVENE AND ESTABLISHING TIME FOR FILING RECOMMENDATIONS

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filling of requests to intervene and for the filling of recommendations.

On September 4, 2009, Southwestern Bell Telephone Company d/b/a AT&T Missouri, filed an application and Motion for Expedited Treatment under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Missouri Public Service Commission review and reverse a decision of the North American Numbering Plan Administrator (NANPA), NeuStar, Inc., to withhold certain numbering resources from AT&T Missouri. The numbering resources AT&T Missouri requested consist of one thousands-block from which 500 consecutive numbers may be drawn which are within: (1) 573 NPA, (2) the Cape Girardeau rate center, (3) a single NXX, and (4) an XXXX range of one of the following: 1000-1499, 2000-2499, 3000-3400, or 4500-4999. The numbering resources are needed in order to meet the

needs of the expanding facilities of the Southeast Missouri Hospital, in Cape Girardeau,
Missouri

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

## IT IS ORDERED THAT:

- 1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.
- 2. Any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than September 18, 2009, with:

- 3. Any other party that wishes to file a recommendation regarding the application of AT&T Missouri, shall do so no later than September 18, 2009, and shall file its recommendation simultaneously with its application to intervene.
- 4. The Staff of the Commission shall file a recommendation regarding the application of AT&T Missouri, no later than September 18, 2009.
  - 5. This order shall become effective September 8, 2009.
