ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: December 22, 2010 Effective Date: January 2, 2011

On November 23, 2010, ATX Licensing, Inc. ("ATX") filed an application requesting its certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled. The application was not signed by a Missouri-licensed attorney and therefore no action was taken on that request.

On November 30, 2010 the Staff of the Missouri Public Service Commission filed a motion requesting the cancellation of the certificate and citing to the November 23, 2010 filing. Staff states in its motion that ATX ceased operations and is no longer in business. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On December 3, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than December 13, 2010. No objections or requests for a hearing were filed.

In File Number XA-2005-0272, the Commission granted ATX a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. MO No. 1, was also approved.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to ATX Licensing, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to ATX Licensing, Inc., in File Number XA-2005-0272, is canceled.

- 2. ATX Licensing, Inc.'s tariff, P.S.C. MO No. 1, is canceled.
- 3. This order shall become effective on January 2, 2011.
- 4. This case may be closed on January 3, 2011.
