**ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY**

Issue Date: December 15, 2011

Effective Date: January 14, 2012

On November 23, 2011, the Staff of the Missouri Public Service Commission ("Staff") filed a motion to cancel the certificate of service authority to provide competitive intrastate interexchange telecommunications services and accompanying tariff granted to Uni-Tel Communications Group, Inc. ("Company"). The Company was granted its certificate on December 28, 1998 in File No. TA-99-215. The Company's tariff, P.S.C. Mo. No. 1, was also approved.

In support of its motion, Staff states that on August 25, 2010, the Missouri Secretary of State's Office revoked the Company's authority to do business as a foreign corporation in the state of Missouri for failure to file a correct and current 2010 annual report, which prevents the Company from carrying on business and lawfully providing telecommunications services in Missouri. In addition, the Company has failed to file its calendar year 2010 annual report with the Commission and is delinquent in the payment of its fiscal year 2011 and 2012 assessments. The Commission received a letter from the former attorney for the Company stating that the Company has not conducted business in Missouri since December 2008. Staff recommends that the Commission cancel the Company's certificate of service authority to provide competitive intrastate interexchange telecommunications services and accompanying tariff.

On November 29, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing no later than December 9, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410(5), RSMo (Supp. 2010), which states that “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.” Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Uni-Tel Communications Group, Inc., shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of service authority to provide competitive intrastate interexchange telecommunications services granted to Uni-Tel Communications Group, Inc. in File No. TA-99-215 is canceled.
2. The Company’s tariff, P.S.C. Mo. No. 1, is canceled.
3. This order shall become effective on January 14, 2012.
4. This case may be closed on January 15, 2012.
