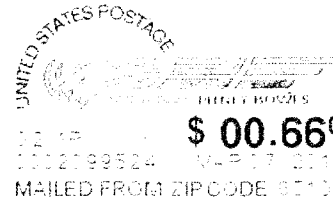
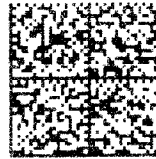

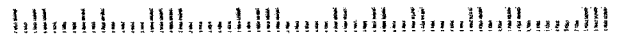

**ORDER CANCELING CERTIFICATE AND
ACCOMPANYING TARIFF**

Issue Date: March 7, 2013

Effective Date: March 17, 2013

On February 20, 2013, the Staff of the Missouri Public Service Commission filed a motion requesting Navigator Telecommunications, LLC (“Navigator”) certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-2000-242, the Commission granted Navigator a certificate of service authority to provide basic local exchange telecommunication service in the State of Missouri. The Company’s tariff, P.S.C. Mo No. 2, was also approved.

Staff states in its motion that the Missouri Universal Service Fund Administrator contacted Staff stating Navigator sent an e-mail from Navigator in July 2012 ad Navigator had indicated they had “no lines” effective July 15, 2012. Navigator’s phone number field with the Commission is no longer in service. Staff believes Navigator is no longer providing service in Missouri and requested the Commission cancel Navigator’s certificate of service authority and accompanying

tariff. Staff noted that Navigator is deficient in the filing of the Company's annual report for calendar year 2012. Navigator is also delinquent on its payment of its fiscal year 2013 assessment. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On February 22, 2013, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than March 4, 2013. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Navigator Telecommunications, LLC, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Navigator Telecommunications, LLC, in File Number TA-2000-242, is canceled.
2. Navigator Telecommunications, LLC's tariff, P.S.C. Mo No. 2, is canceled.
3. This order shall become effective on March 17, 2013.

4. This case may be closed on March 18, 2013.
