COMES NOW the Office of the Public Counsel (Public Counsel) and for its Response to Staff's Recommendation states as follows:

- 1. On May 12, 2009, Oakbrier Water Company, Inc. (Oakbrier) filed an Application and Motion to Expedite Application (Application) seeking a Certificate of Convenience and Necessity (CCN) to expand its current water service territory in and around the subdivision known as Oakbrier Estates, which was previously granted a CCN in Commission Case No. WA-88-128. Oakbrier's Application requested expedited treatment due to a pending small utility rate case, WR-2009-0229, which includes the proposed expanded service area.
- 2. On May 27, 2009, the Staff of the Public Service Commission (Staff) filed its Recommendation which requested that the Commission issue an expedited order granting Oakbrier Water Company, Inc. a certificate of convenience and necessity to provide water service to the expanded area in and around the subdivision known as Oakbrier Estates.

3. Public Counsel now states that it has no objection to Staff's recommendation of an expedited order granting Oakbrier Water Company, Inc. a certificate of convenience and necessity in this expanded area.
