## ORDER AND NOTICE

On May 12, 2009, Oakbrier Water Company, Inc., filed an application as described in the above caption. The Commission will direct that notice of the application be sent to appropriate persons and entities. The company also requests expedited treatment.

The Commission determines that notice of this application should be given by the Commission's Data Center sending a copy of this order to the County Commission of Butler County, Missouri and to the Department of Natural Resources. The Commission further determines that the Information Officer of the Commission shall make this Order and Notice available to the members of the General Assembly who represent constituents in Butler County, Missouri and to the newspapers and other media which serve Applicant's service area.

Those wishing to intervene shall have 9 days from the date of this order to file, with the Secretary of the Commission, an application to intervene and shall send a copy of the application to all parties as directed below. Further, the Commission will require that any opposition to the company's request for expedited treatment be filed and that the Staff of

the Commission, if it does not object to the company's motion for expedited treatment, file a recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall send a copy of this order to the County Commission of Butler County, Missouri and to the Department of Natural Resources.

2. The Commission's Information Officer shall make this Order and Notice available to the members of the General Assembly who represent constituents in Butler County, Missouri and to the newspapers and other media which serve Applicant's service area.

3. Those wishing to intervene shall file an application to do so no later than May 22, 2009, with:

4. Any party objecting to Oakbrier Water Company, Inc.'s request for expedited treatment shall file a response setting out such objection no later than May 27, 2009.

5. The Staff of the Commission, if it does not object to the company's request for expedited treatment, shall file a recommendation no later than May 29, 2009.

6. This order shall become effective upon issuance.
