**NOTICE OF CORRECTION

**COMES NOW** the Staff (“Staff”) of the Missouri Public Service Commission (“Commission”), by and through counsel, and for its *Notice of Correction* in these matters respectfully states:

1. On June 4, 2013, Staff, the Office of the Public Counsel, and Cedar Green Land Acquisition, LLC, jointly filed a *Unanimous Stipulation and Agreement* (“Agreement”) in both WA-2013-0117 and SA-2013-0354. The Agreements in both matters included a Schedule of Depreciation Rates attached as Appendix B.
