1. On February 4, 2015, Ridge Creek Water Company, LLC ("Ridge Creek" or "Company") filed an Application to obtain a certificate of convenience and necessity ("CCN") for authority to construct, install, own, operate, control, manage, and maintain a water system located in an unincorporated area in Pulaski County, Missouri.

2. On September 2, 2015, the Commission approved the Nonunanimous Stipulation and Agreement filed by Ridge Creek, the Department of Natural Resources, and Staff on August 17, 2015. In its order, the Commission ordered Ridge Creek to submit its tariff by September 22, 2015.

3. On September 22, 2015, Ridge Creek filed its tariff bearing an effective date of October 22, 2015. The Commission ordered parties to file their objections to Ridge Creek's tariff (Tracking No. YW-2016-0094) by October 2, 2015.

4. Staff has reviewed the tariff and provided its input to Ridge Creek. As a result of Staff's discussions with the Company, a title page and revised Sheet No. 5 were filed on September 28, 2015. Staff recommends approval of the tariff filed on

September 22, 2015 and incorporating the substitute tariff sheets filed on September 28, 2015.

WHEREFORE, Staff submits its Response to Commission Order and recommends approval of the tariff filed on September 22, 2015 incorporating the substitute tariff sheets filed on September 28, 2015 under tracking number YW-2016-0094.
