

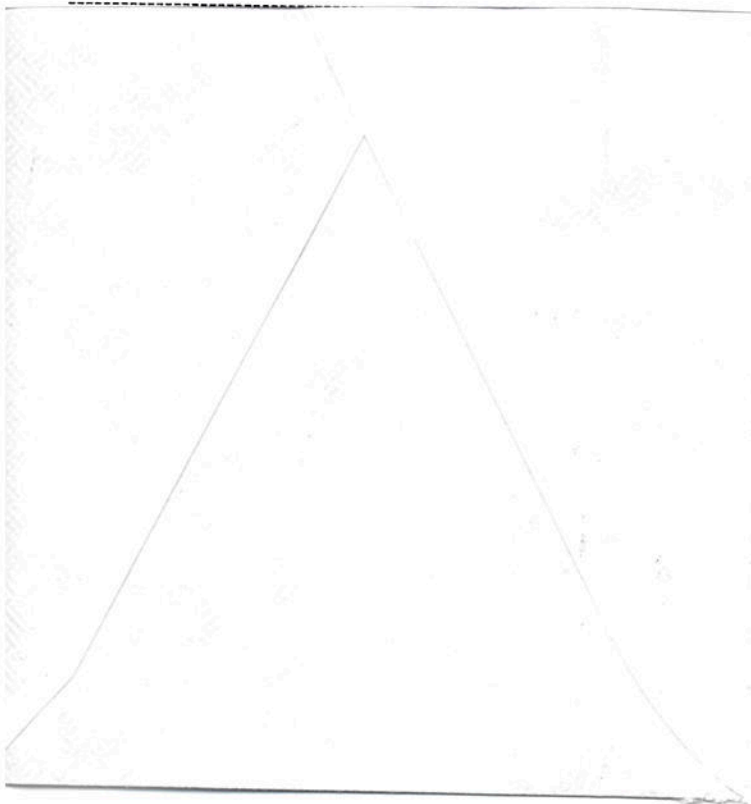

Dear Mr. Kenney:

I am writing this letter to oppose the Grain Belt Express Clean Line Energy extremely high voltage transmission line across Missouri. I think the case number is EA-2014-0207.

The final proposed line is going through our Ralls County farm that has been in the family since 1935. We here in the state of Missouri use very little if any DC current. Everything we use is AC current. Not one of our electric suppliers is supporting this project. I think the Commission will be setting a very dangerous precedent if they grant Clean Line eminent domain status. If eminent domain is granted then any company will be able to build whatever across Missouri.

Farm land is not being discovered even with all the new technology. Easements and highways are going to drive food prices higher. Acres are going out of production agriculture. We farmers work hard to produce food for over 150 people each year. If Clean Line Energy is granted eminent domain status, then your grandchildren will have to eat fruits, vegetables and meat products that are imported and far more expensive.

In short the transmission lines will violate property rights, they will be eye sores, obstacles to farm around even with GPS, limit land use and reduce property values.

The real bottom line is this proposal has no positive merit. We in Missouri do not need it and will get no benefits from it. Thus, it does not qualify to be a utility company that should be granted the power of eminent domain. If you grant eminent domain to this company then you will destroy agriculture on over 5,000 acres of Missouri land.
