## NOTICE OF LOCAL PUBLIC HEARING REGARDING PROPOSED RATE INCREASE

Based upon a request by the Office of the Public Counsel (OPC), a state agency responsible for representing the interests of consumers before the Missouri Public Service Commission (Commission), the Commission will be holding local public hearings regarding proposed changes to the customer rates and charges of Oakbrier Water Company, Inc. (Company). The purpose of this local public hearing is to receive customer comments about the proposed changes to the Company's rates and charges, and to bring service-related problems to the Commission's attention.

The local public hearings will be held October 29, 2012, in Room 203, 200 E.K. Porter Building, Three Rivers Community College, located at 2080 Three Rivers Boulevard, Poplar Bluff, MO, and, October 30, 2012, at the Bootheel Regional Planning Commission, Old Armory, 105 East North Main Street, Dexter, MO. The night's activities for the Poplar Bluff, MO local public hearing will begin with an informal question-and-answer session starting at 5:30 p.m. – with the local public hearing expected to begin at 6:00 p.m. The day's activities for the Dexter, MO local public hearing will begin with an informal question-and-answer session starting at 11:30 a.m. – with the local public hearing expected to begin at 12:00 p.m. The facility at which this local public hearing is being held meets the accessibility standards required by the Americans With Disabilities Act. Any person that needs additional accommodations to participate in the local public hearing should call the Commission's Hotline at 1-800-392-4211 (voice), or Relay Missouri at 711, no later than the end of business on October 26, 2012.

As the Company notified you by a letter dated September 7, 2012, the Company has filed revised tariff provisions to implement new rates for its water services, to reflect a change in the design of its customer rates, and to implement certain new and revised service. A table summarizing the Company's proposed revisions to its rates and charges, and including a monthly customer bill comparison for a residential customer using 6,000 gallons of water, is set out at the end of this notice. In addition, the table corrects the total monthly bill for the current rates and proposed rates. These totals in the September 7, 2012 notice did not accurately reflect the changes resulting from the proposed reduction in the amount of water included in the minimum monthly customer charge from 5,000 gallons to 2,000 gallons.

Any customer that has questions about the local public hearings, that has comments about the Company's proposed revisions to its rates and charges, or that has comments regarding service-related problems should contact the Commission Staff and/or the OPC no later than the end of business on October 30, 2012.
