## **RECOMMENDATION FOR APPROVAL OF TARIFF SHEETS**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its <u>Recommendation for Approval of Tariff Sheets</u> states the following to the Missouri Public Service Commission ("Commission").

- 1. By its **Report and Order** ("Order") issued in this case on June 15, 2006, which was effective on July 1, 2006, the Commission directed Hickory Hills Water & Sewer Company ("Company") to file revised tariff provisions to decrease its annual water system operating revenues by \$840 and authorized the Company to file revised tariff provisions to increase its annual sewer system operating revenues by \$2,413.
- 2. By a letter dated November 1, 2006, which was received in the Commission's Data Center on that same day, Gary V. Cover, the Commission-appointed Interim Receiver for the Company, submitted a revised water rate tariff sheet and a revised sewer rate tariff sheet intended to be in compliance with the Order referenced in Paragraph 1 above. The subject tariff sheets bear an issue date of November 1, 2006 and an effective date of December 1, 2006.
- 3. Upon receipt of the Company's tariff filing, personnel in the Commission's Data Center entered the filing into the Commission's electronic filing and information system, with Tariff File No. YW-2007-0303 being assigned to the revised water rate tariff sheet and Tariff File No. YS-2007-0304 being assigned to the revised sewer rate tariff sheet.

4. The Staff has reviewed the revised rate tariff sheets that the Company submitted on November 1, 2006 and is of the opinion that those tariff sheets are in compliance with the Order referenced in Paragraph 1 above.

**WHEREFORE**, the Staff respectfully recommends that the Commission issue an order that approves the tariff sheets pending in Tariff File Nos. YW-2007-0303 and YS-2007-0304 to be effective on December 1, 2006.
