RECOMMENDATION FOR APPROVAL OF REVISED TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its <u>Recommendation for Approval of Revised Tariff Sheets</u> ("Recommendation") states the following to the Missouri Public Service Commission ("Commission").

- 1. On August 13, 2007 (unless noted otherwise, all dates herein refer to the year 2007), S. K. & M. Water and Sewer Company ("the Company"), the Office of the Public Counsel and the Staff filed a Unanimous Agreement Regarding Disposition of Small Water Company Revenue Increase Request ("Unanimous Agreement"). As a part of the Unanimous Agreement, the Company agreed to submit a substitute tariff sheet containing the rates, charges and language set out in the example tariff sheet that was attached to the agreement, to replace the corresponding revised tariff sheet it originally submitted to the Commission on May 31.
- 2. On August 17, the Company submitted the substitute tariff sheet required by the above-referenced Unanimous Agreement.
- 3. The Staff has reviewed the Company's substitute tariff sheet and hereby states that it is in compliance with the Unanimous Agreement and should thus be approved. Further, the Staff states that the other revised tariff sheet that the Company submitted to the Commission on May 31 is in compliance with the original Company/Staff agreement submitted in this case, did not need to be changed as a result of the Unanimous Agreement, and should thus also be

approved. (Dale Johansen of the Water & Sewer Department reviewed the substitute sheet on behalf of the Staff.)

WHEREFORE, the Staff respectfully recommends that the Commission issue an order that approves the following revised tariff sheets that are currently pending in Tariff File No. YW-2007-0864:
