MOTION TO ACCEPT CERTIFICATE OF NAME CHANGE

COMES NOW Joint Petitioner C III Communications Operations, LLC ("C III Ops") pursuant to 4 CSR 240-2.080 and for its Motion to Accept Certificate of Name Change, states:

- 1) On June 17, 2003, the Commission entered its Order approving Transfer of Assets, in Case No. XA-2003-0356. At paragraph 8 of the Ordered Section, the Commission ordered that C III Ops must file its request to recognize its name change to Broadwing Communications, LLC by June 27, 2003.
- 2) On June 24, 2003, C III Ops filed its Motion to Recognize Name Change Effective July 4, 2003.
- 3) On June 25, 2003, the Commission entered its Order Directing Filing ordering C III Ops to file by June 27, 2003 evidence of registrations of its name change with the Missouri Secretary of State.
- 4) C III states that it filed it's application for name change with the Missouri Secretary of State on or about June 25, 2003.

5) On June 27, 2003, C III filed a Motion for Extension of Time To File Name Change Certificate, asking the Commission to extend the time to file to July 3, 2003. C III expected to receive the name change certificate by July 3, 2003, but has yet to receive the same from the Secretary of State's Office due to a continued back log at the Secretary of State's office.

6) On June 27, 2003, C III filed a Second Motion for Extension of Time To File Name Change Certificate, asking the Commission to extend the time to file to July 11, 2003.

7) C III Ops files herewith Certificate of Correction from the Secretary of State of the State of Missouri indicating that it's name is changed from C III Communications Operations, LLC to Broadwing Communications, LLC, effective June 25, 2003. See Exhibit A attached hereto.

WHEREFORE, C III Ops respectfully requests that the Commission accept this filing in satisfaction of Paragraph 8 of the ordered section of the Commission's Order Approving Transfer of Assets issued June 17, 2003.
