<b>PRO-RATA ADJUSTMENT OF MONTHLY MINIMUM CHARGE</b> – If the customer is forced to close operations of its works for a period of 10 days or more on account of accidents, fires, damage to works, strikes of its own employees, act of God, governmental regulations or other physical cause not reasonably within its control, and customer gives water company written notice not later than forty days after such occurrence, the customer will be entitled to pro rata reduction in the monthly minimum charge which is based on 60% of the maximum usage during the previous months of June, July, August, or September for the period during which the customer is unable to use full water service for such cause.	
<b>DURATION OF CLASSIFICATION</b> – Customers electing Tariff Rate J are required to remain in this classification for a period of at least twelve (12) months.	
A Rate J customer whose usage is less than 450,000 gallons per month more than two times during a twelve (12) month period will no longer meet the eligibility requirements of this classification.	
Customers who no longer meet the eligibility requirements of this classification, or elect to leave this classification, will be reclassified to Tariff Rate A, and must remain in the Rate A classification for a minimum of twelve (12) months and meet the monthly minimum usage requirements again before being reclassified under the Tariff Rate J.	+

The program administrator will determine a customer’s eligibility using the following criteria: the customer’s household earnings meet the low-income guidelines for the Missouri Low-Income Home Energy Assistance Program (LIHEAP). Residential customers, who demonstrate a financial need and qualify for LIHEAP, should contact a local Community Action Agency referenced below or any subsequent program administrator whose contact information may be found on Missouri American Water’s web site. Upon qualification for LIHEAP, residential customers with a 5/8” meter will receive a discount of 80% of the fixed 5/8” meter minimum customer charge. The current fixed monthly 5/8” meter minimum customer charge for St. Joseph, Brunswick and Platte County is \$9.00, the discount applied to the customer’s monthly bill would be \$7.20.

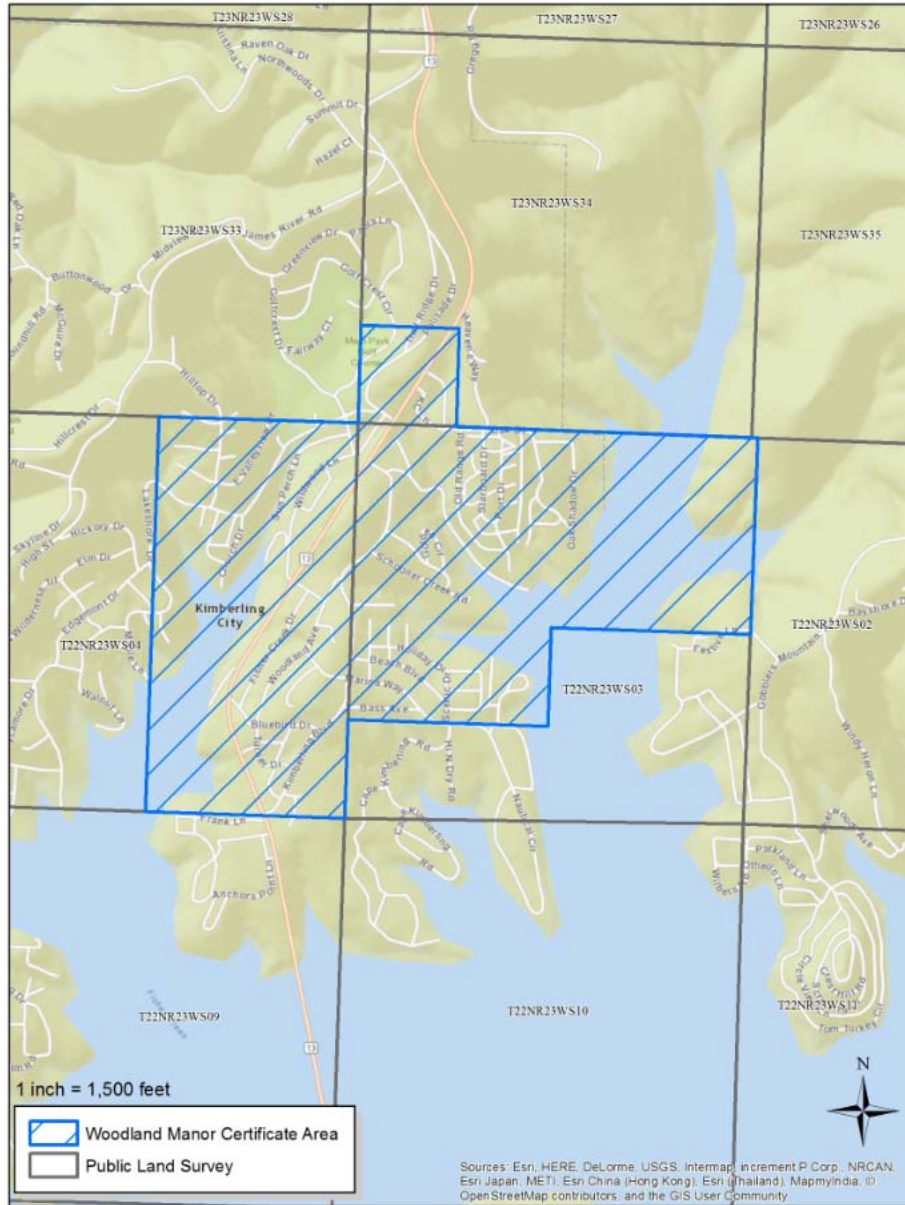
