## ORDER GRANTING MOTION TO CONTINUE HEARING AND AMENDING PROCEDURAL SCHEDULE

On December 13, 2017, the Commission issued an *Order Setting Procedural Schedule and Other Procedural Requirements*, which set an evidentiary hearing in this matter for February 22-23, 2018. On February 15, 2018, Gascony Water Company, Inc. filed a *Motion to Continue* stating that the owner of the company and witness at the hearing is in the hospital with the flu and unable to assist the company or appear at the hearing. The company represents that all the other parties to this case do not object to postponing the hearing until March 19, 2018. The Commission finds the request reasonable and will grant the motion for continuance, set a new date for the evidentiary hearing, and adjust the deadline for other case filings.

#### THE COMMISSION ORDERS THAT:

- 1. Gascony Water Company, Inc.'s *Motion to Continue* is granted.
- 2. The evidentiary hearing is rescheduled for Monday March 19, 2018, beginning at 9:00 a.m. The hearing will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.

- 3. The deadline for filing position statements is extended until no later than March 12, 2018.
- 4. The deadline for submitting exhibit lists is extended until no later than March 15, 2018.
  - 5. The deadline for filing initial briefs is extended until no later than April 6, 2018.
- 6. The deadline for filing reply briefs is extended until no later than April 13, 2018.
- 7. All other provisions of the Commission's *Order Setting Procedural Schedule* and *Other Procedural Requirements* shall remain in effect.
  - 8. This order shall be effective when issued.
