NOTICE OF COMPLAINT

Issue Date: February 2, 2017 Effective Date: February 2, 2017

On February 1, 2017, Michael Brower filed a complaint with the Missouri Public Service Commission against Branson Cedars Resort Utility Company, LLC (the Company) alleging that the Company was charging for two services when only one service connection exists in a single family dwelling. Further, Mr. Brower alleged that there was no meter in place in violation of the Company's tariff.

Pursuant to Commission Rule 4 CSR 240-2.070, the Company has 30 days from the date of this notice to file an answer. Since this notice is being issued on February 2, 2017, the answer is due no later than March 4, 2017.

Provisions governing procedures before the Commission are found in Commission Rule 4 CSR 240, Chapter 2. In particular, the procedures relating to discovery are found at Commission Rule 4 CSR 240-2.090.
