On April 16, 2018, Paul and Linda Frank (the “Franks”) filed a complaint against Missouri-American Water Company (“MAWC”). On May 30, 2018, the Franks and MAWC submitted a *Joint Request for Dismissal* stating that the two parties resolved their dispute with the Franks receiving a credit adjustment of \$196.89 from MAWC.
