NOTICE OF SMALL FORMAL COMPLAINT AND ORDER DIRECTING STAFF TO INVESTIGATE AND FILE A REPORT

On September 21, 2020, the Missouri Public Service Commission (Commission) received an email from Jack and Stacey Woolever regarding a complaint against Missouri-American Water Company (MAWC). The Woolevers requested that the email be attached to their "recently submitted complaint with MAWC." On September 24, 2020, the Commission issued a *Notice of Deficiency and Order Directing Filing* that directed the Woolevers to submit additional information as required by Commission Rule 20 CSR 4240-2.070 in order for the Commission to consider the email as a formal complaint. On October 20, 2020, the Commission received the formal complaint and cover letter explaining that there had been a delivery delay with the United States Postal Service when the complaint was first mailed to the Commission. The Commission will now give notice of the complaint, set a time for filing an answer, and direct the Staff of the Commission to conduct an investigation and file a report.

Because this complaint involves less than \$3,000, it shall proceed under the Commission's small complaint procedure at 20 CSR 4240-2.070(15). If any party believes that this matter should not proceed under the small complaint procedure, that party may file a motion consistent with the Commission's rule.

Under Commission Rule 20 CSR 4240-2.070(15), MAWC shall have 30 days from the date of this notice to file a response to the complaint. Additionally, a copy of the answer or response shall also be served upon the Woolevers at the address provided.

In accordance with the Commission's procedural rules, the Commission will direct the Staff of the Commission to investigate this complaint and file its report detailing its findings and recommendations. The Commission will also send a copy of its procedural rules to the Complainant and a copy of its mediation procedures to both parties. As required by Section 536.067(2)(f), RSMo (2016), the Commission informs the parties that the Commission's provisions governing procedures before the Commission, including provisions relating to discovery, are found at Commission Rule 20 CSR 4240-2.090.

THE COMMISSION ORDERS THAT:

- 1. Missouri-American Water Company shall file a response to this complaint no later than December 20, 2020.
- 2. The Staff of the Commission shall investigate and file a report detailing its findings and recommendations no later than January 8, 2021.
