ORDER GRANTING EXTENSION OF TIME

On April 15, 2022, the Staff of the Commission (Staff) filed complaints against Northgate MHP Lindale, LLC, d/b/a Northgate Manufactured Home Community (Northgate Lindale). The Commission gave notice and directed Northgate Lindale to file its answer on or before May 19, 2022.

On May 20, 2022, counsel for Northgate Lindale entered his appearance and requested an extension of time to file Northgate Lindale's answers. The request states

that counsel has not had a reasonable opportunity to confer with Northgate Lindale and prepare responsive pleadings. Northgate Lindale requests until June 3, 2022 to file its answers.

The Commission considers the request to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Northgate Lindale's request for an extension of time is granted. Northgate Lindale shall file answers to the complaints on or before June 3, 2022.
2. This order shall be effective when issued.
