ORDER SETTING HEARING ON MOTION TO COMPEL

On April 14, 2023, the Staff of the Commission (Staff) filed a motion to compel I-70 Mobile City, Inc. d/b/a I-70 Mobile City Park to answer data requests. Staff’s motion contends that I-70 Mobile City Park failed to respond to specific data requests and failed to update answers to prior data requests. I-70 Mobile City Park responded to Staff’s motion and requested a motion hearing.

The Commission will set a date to hear arguments about Staff’s motion to compel.

THE COMMISSION ORDERS THAT:

1. The Commission will hold a motion hearing on May 9, 2023, beginning at 1:30 p.m., in room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.
