On May 16, 2022, the Commission’s Staff (Staff) filed a motion to consolidate the above captioned complaints. Staff submits that there are common questions of law and fact in these complaints and their consolidation would be administratively expedient and simplify filings. No responses were received to Staff’s motion to consolidate.<sup>1</sup>

On May 31, 2022, I-70 Mobile City, Inc. d/b/a I-70 Mobile City Park filed its answers to Staff’s complaints. The Commission may now consider the complaints.

The Commission will consolidate these complaints and direct Staff to consult with the other parties and submit a proposed procedural schedule.
