**APPLICATION FOR APPROVAL OF AMENDMENT
TO AN INTERCONNECTION AGREEMENT**

COMES NOW YMax Communications Corp., ("Applicant" or "YMax"), by its undersigned counsel, and pursuant to 4 CSR 240-2.060 and 4 CSR 240-3.513(6)(C), files its Application for Approval of Amendment to a previously approved Interconnection Agreement between Applicant and Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri ("AT&T Missouri"). In support of this Application, YMax states as follows:

1. Applicant YMax Communications Corp. is a corporation duly organized and existing under and by virtue of the laws of the State of Delaware, duly authorized to conduct business in the State of Missouri. The nature of the Applicant's business is telecommunications. Pursuant to 4 CSR 240-2.060(1)(C), the Certificate of Authority to transact business in Missouri issued by the Secretary of State which was filed in Case No. CA-2006-0373 is hereby incorporated by reference. Applicant's principal place of business is 5700 Georgia Avenue, West Palm Beach, Florida 33405. Its telephone number is 561-832-3021 and its toll-free customer service number is 1-888-230-0060. YMax officer's verification of this Application is attached hereto.

2. Applicant states, in accordance with 4 CSR 240-2.060(1)(K), that there are no pending actions or final unsatisfied judgments or decisions against Applicant in any state or federal agency or court which involve customer service or rates, which action,

judgment or decision has occurred within three (3) years of the date of this Application. Pursuant to 4 CSR 240 240-2.060(1) (L), Applicant states that the Company does not have any overdue annual reports or assessment fees owed to the Commission.

3. Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri, is an Incumbent Local Exchange Carrier (ILEC). AT&T Missouri is a Texas limited partnership with its principal offices in Missouri located at One AT&T Center, Room 3520, St. Louis, Missouri 63101. AT&T Missouri adopted its current fictitious name in Missouri subsequent to execution of this Agreement, as authorized by the Commission in Case No. IN-2006-0232. This change in fictitious name does not alter the identity of the parties to the agreement.

4. All communications, notices, orders and decisions respecting this Application and proceeding should be addressed to:

5. An interconnection agreement between AT&T Missouri and YMax was approved by the Commission in Case No. CK-2007-0057 (Order Approving Interconnection Agreement issued September 12, 2006; effective September 22, 2006).

6. The parties have agreed to amend their Interconnection Agreement with an Amendment to revise Appendix ITR, replacing one section; namely Section 5.7.1 of Appendix ITR. This amendment does not appear to qualify for informal submission via

cover letter under the Commission's rule for "Amendments previously approved by the Commission" (4 CSR 240-3.513(6)(A). Thus, pursuant to 4 CSR 240-3.513(6)(C), Applicant presents this amendment to the Commission for approval. The amendment will be submitted in the Commission's Electronic Filing Information System (EFIS) separately from this Application. The three-page amendment bears the heading "AMENDMENT – REVISE APPENDIX ITR/**AT&T-12STATE**".

7. This Amendment resulted from negotiations between AT&T Missouri and YMax, and is not discriminatory against any telecommunications carrier. The amendment is consistent with the public interest, convenience and necessity. As stated above, to Applicant's knowledge, this particular interconnection agreement amendment has not been previously approved by the Commission, prompting this Application pursuant to 4 CSR 240-3.513(6)(C).

WHEREFORE, for the foregoing reasons, YMax Communications Corp. respectfully requests that the Commission approve the Amendment to the Interconnection Agreement between YMax and AT&T Missouri.
