ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: May 23, 2017

Effective Date: June 2, 2017

On May 4, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting National Directory Assistance, LLC's ("National Directory") certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled.

In File Number TA-2002-476, the Commission granted National Directory a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that National Directory notified the Commission in its FY2018 Assessment Statement of Revenue that National Directory wished to voluntarily surrender its certification to provide telecommunications services in Missouri and requested the Commission cancel National Directory's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On May 5, 2017, the Commission issued an Order Establishing Time to Respond allowing parties until May 15, 2017, to file an objection or request a

hearing. No objections or requests for a hearing were filed.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to National Directory Assistance, LLC, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to National Directory Assistance, LLC, in File Number TA-2002-476, is canceled.
2. National Directory Assistance, LLC’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on June 2, 2017.
4. This case may be closed on June 3, 2017.


