ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 18, 2018

Effective Date: February 17, 2018

On December 8, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting Protocall Telecom, LLC's ("Protocall") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunications services in the State of Missouri be cancelled.

In File Number XA-2009-0402, the Commission granted Protocall a certificate of service authority to provide intrastate interexchange telecommunications services in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that on October 19, 2017, the company notified the Commission that it no longer wished to retain its certification to provide telecommunications service. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On December 27, 2017, the Commission issued an Order Establishing Time to Respond allowing parties until January 6, 2018, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Protocall, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide basic local exchange and interexchange telecommunications services granted to Metro Communications Company, in File Number XA-2009-0402, is canceled.
2. Protocall Telecom, LLC’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on February 17, 2018.
4. This case may be closed on February 18, 2018.
