#### MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of interexchange service authority and applicable tariff of Worldwide Telecommunications, Inc. (Company) and states:

- 1. The Commission previously granted a certificate to the Company on October 7, 2008, to provide intrastate interexchange service authority in Case No. XA-2009-0055. The Company has a currently effective tariff, Tariff No. YX-2009-0148.
- 2. The Company notified the Commission November 27, 2018, that it wished to voluntarily relinquish all of its authority in Missouri in a letter attached as Appendix A.
- 3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. W.D. 1989).

**WHEREFORE,** Staff respectfully recommends the Commission cancel the certificate of service authority to provide interexchange telecommunications services in Missouri and applicable tariff of Worldwide Telecommunications, Inc.

#### Section 63.71 Application of Worldwide Telecommunications Inc.

Worldwide Telecommunications Inc. ("Worldwide Telecommunications" or "Applicant"), hereby seeks authorization pursuant to Section 214 (a) of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71, to discontinue the provision of intrastate and interstate long distance services in the states of Arkansas, Iowa, Michigan, Missouri, Ohio, Virginia and Washington.

Applicant is considered a non-dominant telecommunications carrier with respect to all of its services, including those affected by the proposed discontinuance.

#### 2. Date of Planned Service Discontinuance, Reduction or Impairment:

Worldwide Telecommunications proposes to discontinue the services that are the subject of this Application on or about December 19, 2018, pending required federal and state regulatory approval of the discontinuance.

#### 3. Points of Geographic Areas of Service Affected:

Worldwide Telecommunications will discontinue service in Arkansas, Iowa, Michigan, Missouri, Ohio and Washington.

#### 4. Brief Description of Types of Service Affected and Reason for Discontinuance:

Worldwide Telecommunications proposes to discontinue all service in Arkansas. Iowa, Michigan, Missouri, Ohio and Washington.

The services are being discontinued because Worldwide Telecommunications has a very small base in the affected states and does not anticipate growth in customer base. Consequentially, it is not economically viable to continue to offer service in these states. As described below, Worldwide Telecommunications is providing all affected customers with ample notice of the discontinuance.

#### 5. Brief Description of Dates and Methods of Notice to All Affected Customers:

The Applicant has provided written customer notice of the planned discontinuance in accordance with the requirements of section 63.71 (a) of the Commission's Rules. Notice was provided via E-mail to all affected customers on November 19, 2018. The notice is attached as Exhibit A.

A copy of this Application is being sent to the state regulatory commissions and governors' offices in all affected states, as well as the Department of Defense, as required under Section 63.71, concurrent with this filing. A service list is provided in Exhibit B.

#### Conclusion

Worldwide Telecommunications Inc. respectfully requests that the Commission approve its Section 63.71 Application to discontinue the services described herein. Pursuant to Section 214(a) of the Communication Act of 1934, as amended, and 47 C.F.R. §63.71. Worldwide Telecommunications understands that this application will be automatically granted on the 31st day after the Public Notice is released, with no Commission notification to the Company, unless the Commission has notified the Company that the grant will not be automatically effective.
