ORDER RECOGNIZING CHANGE OF CORPORATE NAME
AND APPROVING TARIFF

On December 15, 2006, The Pager Company d/b/a The Pager & Phone Company (“Pager Company”) filed a letter notifying the Missouri Public Service Commission of a corporate name change to YourTel America, Inc. (“YourTel”). Accompanying the letter were documents showing that Pager Company amended its Articles of Incorporation to change its corporate name to YourTel on December 4, 2006, and that the Missouri Secretary of State issued a Certificate of Amendment registering the name change on December 7, 2006. Two revised tariff sheets which reflect the name change and have an effective date of January 17, 2007 were also attached to the letter, including an adoption notice and a replacement title sheet. Finally, the letter included a copy of a notice prepared by Pager Company informing its customers of the name change, which is scheduled to be delivered on or before Pager Company’s next billing cycle.

On December 19, 2006, the Commission directed its Staff to commence an investigation and promptly file a report containing its recommendation as to whether the Commission should recognize Pager Company’s name change and approve the accompanying revised tariff sheets. On December 29, 2006, the Staff of the Commission

filed a verified Memorandum recommending that the Commission recognize Pager Company's name change and approve the accompanying tariff sheets with an effective date of January 17, 2007. Staff notes that Pager Company is currently authorized to provide competitive interexchange telecommunications services in the state of Missouri through a certificate issued by the Commission in Case Number XA-2003-0118, and that Pager Company's letter and attachments comply with the applicable Commission Rules governing utility company name changes and setting forth filing requirements for telecommunications company tariffs.¹

The Commission has reviewed Pager Company's pleadings and Staff's Memorandum, and finds that the change of name to YourTel will be recognized. The Commission further finds that the revised tariff reflecting the change of name will be approved.

IT IS ORDERED THAT:

1. The change of name from The Pager Company d/b/a The Pager & Phone Company to YourTel America, Inc. is recognized.
2. YourTel America, Inc.'s revised tariff, Tariff No. YX-2007-0420, is approved to become effective on January 17, 2007. The tariff approved is:
