On April 5, 2007, Inmate Calling Solutions, LLC d/b/a ICSolutions ("ICSolutions") filed a letter requesting that the Missouri Public Service Commission acknowledge its recent corporate name change from Inmate Calling Solutions, LLC ("ICS") and approve a replacement tariff reflecting that name change.

Accompanying the letter is a document showing that ICS registered the fictitious name "ICSolutions" with the Missouri Secretary of State on January 31, 2007, and that this registration does not expire until January 31, 2012. Also attached to the letter is a replacement tariff reflecting the company's new name, Inmate Calling Solutions, LLC d/b/a ICSolutions.¹

Although the letter does not indicate whether the company's customers have been or will be notified of the name change, its submission is in substantial compliance with the applicable Commission Rules governing the contents of applications for Commission

acknowledgment of corporate name changes and setting forth filing requirements for telecommunications company tariffs.²

The Commission would like to have the benefit of a brief investigation by its Staff before it further considers this matter. Therefore, Staff will be directed to commence an investigation and promptly file a report containing its recommendation as to whether the Commission should recognize ICSolutions's name change and approve the accompanying replacement tariff.

IT IS ORDERED THAT:

1. The Staff of the Missouri Public Service Commission shall promptly commence an investigation into the merits of the application filed by Global Internetworking, Inc. on April 5, 2007.

2. The Staff of the Missouri Public Service Commission shall file a report concerning the results of its investigation by no later than Friday, April 27, 2007.

3. This order shall become effective on April 6, 2007.
