### **STAFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission recognize the use of the fictitious name "ICSolutions" by Inmate Calling Solutions, LLC.

2. The company has fulfilled the requirements of the Commission's rule governing name changes at 4 CSR 240-2.060(5) in that the request contains (1) a Registration of Fictitious Name issued by the Missouri Secretary of State (demonstrating that Inmate Calling Solutions, LLC has registered the name ICS Solutions for use in Missouri); and (2) new tariff identifying the new name.

3. As Staff notes in the attached Memorandum, the company provides service to inmates and provides automated operator assisted calling services to inmates. No direct customer notice can be provided because the company does not have address or contact information of the inmates or the people inmates call. The company will notify the correctional facility management personnel of the names of the providers who serve their facilities and will provide information on its website. Thus, Staff finds that the company has met the requirements of 4 CSR 240-3.545(20).

The company has submitted new tariff sheets with an effective date of May 5,
 Staff has reviewed the new tariff sheets and recommends that the Commission approve them.

**WHEREFORE,** Staff recommends that the Commission issue an order acknowledging that Inmate Calling Solutions, LLC will do business under the fictitious name of ICSolutions; and approving the tariff sheets filed to effectuate that name change with an effective date of May 5, 2007.
