The Missouri Public Service Commission grants the application for recognition of

the following name change:

From: Inter-Tel NetSolutions, Inc.

- To: Mitel NetSolutions, Inc.
- For: interexchange telecommunications.

)

On April 22, 2009, the Commission received the application, with an adoption notice effective May 22, 2009. On April 27, 2009, the Commission received a substitute tariff sheet effective May 27, 2009. On May 1, 2009, the Commission's Staff filed its verified recommendation supporting approval of the application.

Such an application must include:

(A) A statement, clearly setting out both the old name and the new name;

* * *

(C) [An] adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application[.¹]

Those items are present in the application. In addition, the application must include:

(B) Evidence of registration of the name change with the Missouri secretary of state[.²]

That item is present because the application includes a copy of an amended certificate

of authority from the Missouri secretary of state. Staff also states that no annual report,

annual assessment fee, and Missouri Universal Service Fund remittance due the

Commission is past due.

Because the application meets the Commission's standards, the Commission grants the application and recognizes the name change.

The Commission orders that:

1. The name change of Inter-Tel NetSolutions, Inc., to Mitel NetSolutions, Inc., is recognized.

2. The revised tariff sheet issued by Mitel NetSolutions, Inc., on April 27, 2009, as tariff tracking number YX-2009-0752 is approved to become effective on May 27, 2009.
