On September 7, 2022, Union Electric Company d/b/a Ameren Missouri filed a tariff for its Weather Normalization Adjustment Rider. That tariff bears an effective date of November 1, 2022.

The Commission's Staff filed its Recommendation on October 12, 2022, recommending that the Commission approve the tariff. The Commission allowed other parties until October 14, 2022 to respond. The Commission received no other responses.

The Commission reviewed the tariff filing and Staff's Recommendation. The Commission will approve the tariff.
