ORDER CHANGING DATE OF HEARING

On October 12, 2018, Union Electric Company, d/b/a Ameren Missouri, the Staff of the Commission, Renew Missouri Advocates, the Missouri Industrial Energy Consumers, the Missouri Department of Conservation, the Missouri Department of Economic Development – Division of Energy, the Natural Resources Defense Council, and the Office of the Public Counsel filed a Third Stipulation and Agreement that would resolve all but one narrow issue. Along with the stipulation and agreement, the parties filed a motion asking the Commission to schedule a hearing to address the sole remaining issue on one of the reserved hearing dates. In parenthesis, the motion indicated October 31 to November 3, although the hearing was scheduled to begin on October 30. On October 15, the Commission issued an order that cancelled the last three days of the hearing and indicated the hearing would begin at 9:00 a.m. on October 30.

The Office of the Public Counsel filed a motion on October 16, asking the Commission to change the hearing date, explaining that its witness will not be available on October 30. Public Counsel requests the hearing be moved to one of the other original hearing dates, October 31, November 1, or November 2. The motion represents that

Ameren Missouri and Staff, the other parties that will have witnesses at the hearing, do not oppose changing the hearing date.

The Commission will change the hearing date as requested.
